## Minutes of Annual Meeting – Wednesday, June 12, 10:00am-10:30am

he 86th Annual Meeting of Hancock-Wood Electric Cooperative, Inc., was held virtually on June 12, 2024, at the Hancock-Wood Electric Cooperative Office, North Baltimore, Ohio. Chairman Gene Barker opened the meeting at 10:00 a.m. Vice Chair Bill Kale provided the invocation.

Barker called the meeting to order at 10:00 a.m. and Duane Fry Secretary/Treasurer, read the Official Notice of the Annual Meeting and the Proof of Mailing. Barker announced last year's Annual Meeting minutes, from June 11, 2022, were distributed and called for a motion to dispense with the reading of the minutes. A motion was made by HWE member Andy Fisher and seconded by HWE member Jennifer Huffman to approve the minutes as presented. The motion passed.

The Election Committee report was given by the chair of the Election Committee, Duane Fry. The Board of Trustees recommended six changes to the Code of Regulations in the 2024 election. The results are as followed:

Change 1 – removal of membership certificates – Passed

Change 2 - service area more defined - Passed

Change 3 - extending term limits - Passed

Change 4 – uncontested election update – Passed

Change 5 - separating secretary and treasurer - Passed

Change 6 - capital credit via electronic notice - Passed

This year districts 1, 4 and 5 requested interested members to submit petitions to run for a board seat.

## The election committee report is as follows:

- Tim Phillips representing district 1.
- Max Rader representing district 4.
- Ed Crawford representing district 5.

A motion was made by Fisher to accept the Election Committee report as presented, and Huffman seconded the motion. Pat Sadowski, the corporate general counsel, swore in the trustees.

Earl Ridlen, managing partner with LWG CPA presented the audit results with a clean opinion for the audit statement of Hancock-Wood.

Barker presented his report to members. He reviewed the following items: trustee accomplishments strategic planning update, 2023 ACSI survey, 2023 patronage reimbursement to members, new member appreciation day format, and an update on the economic development progress.

Barnhart gave the president's report. He reviewed 2023 staffing updates, outage statistics for 2023, and the cooperative's future plans.

Pat O'Loughlin President and CEO of Ohio's Electric Cooperatives provided a statewide update.

Barker adjourned the meeting at 10:33 a.m.

# STATEMENT OF NONDISCRIMINATION
