# MESSAGE FROM THE GENERAL MANAGER Hancock-Wood Electric Cooperative has another successful year

n June, the Hancock-Wood Electric Cooperative Board of Trustees held the 86th annual meeting for the members. I am happy to report the cooperative continues to maintain our positive financial standing and has completed several goals over the past year, while also providing safe and reliable electricity to our membership.

### The 2024 trustee election results are as follows:



Tim Phillips was

reelected to serve as

the District 1 trustee.



Ed Crawford was reelected to serve as

Max Rader was elected to serve as the District 5 trustee. the District 4 trustee.

### All six of the proposed Code of **Regulations changes were approved by** the membership. Those changes included:

- 1. The removal of membership certificates, which were deemed unnecessary and created administrative burdens.
- 2. The service area definition was also updated to better clarify eligibility for membership.
- 3. The term limits for board members were extended from four to five terms, allowing for more continuity and retaining knowledge and investment in the trustees.
- 4. Uncontested election procedures update. The change in subsection (b) clarifies that the cooperative need not send ballots to the membership for uncontested elections, saving on postage and administrative cost.
- 5. Separating secretary and treasurer. The change in Section 9 cleans up language regarding the assistant secretary (which is covered in new Section 10) and splits the officer descriptions between secretary and treasurer (and assistant secretary and assistant treasurer). The office of secretary and treasurer (and assistant secretary and assistant treasurer) may still

be served by one person, consistent with past practice.

6. Capital credits via electronic notifications. It is sometimes

very difficult to track down members to reimburse their capital credits. Notably, if a member moves from the service area without a forwarding address, it does little good to send a letter to a former address and give notice in the cooperative newsletter, which the former member no longer receives. The cooperative proposes also adding electronic notice through the cooperative website or otherwise (e.g. email) to give the departing member more opportunities to claim the unreimbursed capital credit

The changes aim to improve efficiency, reduce costs, and make it easier for members to claim unreimbursed capital credits. The updates will help the cooperative better serve its members and improve its overall operations.

Hancock-Wood's primary goal is to deliver the highest possible quality of electric service, safely, at a fair price. The key measure of quality in the eyes of our members is the number of times their lights go out. In 2023, the average member experienced slightly less than one outage and a total of 70 outage minutes for the year. Hancock Wood crews responded quickly and safely to address outage issues. Even though our electrical system totals almost 1,587 miles of line and covers 10 counties, the average length of an outage was only 81 minutes. When compared to our five-year averages, members experienced half as much outage time. Our crews were not only available 24/7 to respond to electric service issues for our members, but they also provided mutual aid to other Ohio cooperatives, such as Midwest. By reaching out to assist other electric cooperatives with outage restoration, our crews demonstrate the cooperative principle of Cooperation among Cooperatives.

Hancock-Wood also reported on cooperative staffing changes, retirements, our safety improvement plan, Amplex partnership, and an update to our economic development efforts. To hear the entire update, visit our website www.hwe.coop or our YouTube page to watch the 2024 Annual Meeting.



# SCHOLARSHIP OPPORTUNITIES

### **ELIGIBILITY**

To be eligible for the Hancock-Wood scholarship, applicants must be the child or legal ward of an HWE member or the child/ ward of a person living on Hancock-Wood's lines. If your parents are Hancock-Wood members in their own name, regardless of residency, you are eligible to apply. Children of renters are only eligible if their parents receive electricity in their name, and employees of businesses on Hancock-Wood's lines and their children are not considered Hancock-Wood members.
