APPLICATION FOR RESIDENTIAL MEMBERSHIP AND ELECTRIC SERVICE*

Hancock-Wood Electric Cooperative, Inc., 1399 Business Park Drive South, North Baltimore, OH 45872

The undersigned (hereafter called Applicant) wishing to secure electric service, as provided by Hancock-Wood Electric Cooperative, Inc. (hereinafter called the Corporation) hereby applies for membership in said Corporation and agrees to comply with all provisions** of the Articles of Incorporation, Code of Regulations and General Terms and Conditions of the Corporation, as currently exist or as may be amended from time to time, and the Applicant further agrees that he/she will pay to the Corporation for the electric service provided at rates established or to be established by the Board of Trustees of the Corporation. To secure applicant's obligation to pay for services provided by the Corporation to the applicant, and in return for those services provided, applicant agrees to and hereby grants to the Corporation, a security interest in capital credits allocated by the Corporation to the applicant.

The Applicant agrees to permit access to his/her premises for all purposes necessary to operate the electric distribution system of the Corporation, including the setting of necessary poles and anchors located on the Applicant's premises and to allow the cutting down or trimming of all trees and spraying of foliage under or near electric line(s), in accordance with the Corporation's tree maintenance policies, and to permit entry in and upon said premises to remove said Corporation's property upon termination of this contract. It is understood that, whenever any digging or trenching is performed by the Corporation, for installation or maintenance, the operation will be carried out in a workman-like manner. All surplus of dirt and debris will be removed and the area left in a neat condition. Any resodding or landscaping required because of installation or maintenance of underground facilities will be the responsibility of the member owner. Applicant also hereby applies for a subscription to *Cooperative Living* magazine and agrees that the monthly charges for electric service shall include the cost of such subscription. The current rate for such subscription is \$.49 per month (\$5.88 per year).
